ORDER:

In the reference 1st read above, the Commissioner of Commercial Taxes, Telangana, Hyderabad has stated that the Commercial Taxes Department in the Telangana State is divided into (14) divisions, and these divisions are organized into (118) circles. It has further stated that though the top tax-payers are being monitored in STU at division level, there is no such mechanism at State level. In the reference 2nd cited, the Department has been reorganized into 19 Divisions and 121 Circles.

2. The Commissioner of Commercial Taxes, Telangana, Hyderabad has submitted proposals to create a State Large Taxpayers Unit (LTU) in the O/o. Commissioner of Commercial Taxes, comprising of the taxpayers based on the following criteria:

1. Top GST taxpayers contributing SGST revenue (Cash + Settlement) of above certain amount per year.
2. GST taxpayers who claim refunds (All GST Acts) above a certain amount per year.
3. Major tax payers under VAT Act, who are dealing in non-GST goods namely, Petroleum Products and Alcoholic Liquor for human consumption.

3. Government after careful examination of the proposals submitted by the Commissioner of Commercial Taxes in the reference 1st read above, hereby accord permission to the Commissioner of Commercial Taxes, Telangana, Hyderabad to take further action as under:

1. Creation of a State Large Taxpayers Unit (LTU), headed by Joint Commissioner(ST)/ Addl.C(ST) Grade 1/ Addl C(ST) and in the O/o. Commissioner of Commercial Taxes.
2. Functioning of State Large Taxpayers Unit (LTU) with the available Officers/ Staff in the Department as mentioned under administrative structure in the reference 1st read above.
3. Constitution and re-constitution of State Large Taxpayers Unit (LTU) with such taxpayers fitting the criteria as proposed every two years or on need basis.
4. Re-distribution of taxpayers among the Division STUs.
5. Notify shifting of posts of Abids STU-3, Panjagutta STU-3, Begumpet STU-3, Warangal STU-2 to State Large Taxpayers Unit (LTU) in the O/o. Commissioner of Commercial Taxes .
6. Procure desktops, printers, scanners and furniture required for State LTUs and to meet the budget of Rs.261.50 Lakhs from the B.E. 2026-27 as per the reference 3rd read above.

5. The Commissioner of Commercial Taxes, Telangana, Hyderabad shall take necessary action in the matter accordingly.
