**ORDER:-**

In the reference 1<sup>st</sup> cited, the seniority list of Superintendents Grade-I (Gazetted), in O/o Commissioner (CT), TG, Hyderabad, was finalized for the panel years 2017-18.

In terms of the orders issued by the Government in the reference 2<sup>nd</sup> cited, in Para (6) it is clearly clarified that the reservation in promotion in favour of Scheduled Casts and Scheduled Tribes, shall be implemented in promotion all the categories of posts, in all services whose total Cadre Strength is more than Five. Basing on the above clarification, the rule of reservation in case of SC/ST need not be implemented in the cadre of Superintendents Grade-I (Gazetted), as the cadre strength is also (5) Five of Superintendents Grade-I (Gazetted) in the O/o Commissioner of Commercial Taxes, Telangana, Hyderabad.

In the reference 3<sup>rd</sup> cited, a show cause notice was issued for preparation of the seniority list of Superintendents Grade-I (Gazetted) for further period for calling objections if any in the matter.

In pursuance of the above show cause notice, no objections have been received after completion of stipulated time.

In view of the above, the proposed show cause notice issued vide reference 3<sup>rd</sup> cited for finalisation of seniority list of Superintendents Grade-I (Gazetted), O/o Commissioner of Commercial Taxes, Telangana State, Hyderabad is hereby confirmed and enclosed as Annexure to this order.

The above seniority list is subject to outcome of SLPs/WPs/OAs, etc., pending, if any, before the Hon'ble Courts and disposal of appeals, revisions, representations if any pending before the competent authority.
