ORDER:

In the reference 4th cited, the proposed seniority list of Senior Assistants/Senior Stenographers of O/o Commissioner of Commercial Taxes, Telangana State, Hyderabad was prepared and show cause notice was issued to the affected persons were requested to file their written objections, if any, with fifteen (15) days, failing which it will be construed that they have no objections to the proposed seniority.

Aggrieved by the above show cause notice, the following objections were received in the matter. The details as follows:

i) Objection of Sri A. Laxmaiah, Senior Assistant: The individual has stated that as per rule of reservations in promotions, the roster point No.8 is earmarked for ST-(W) and the said point was filled with General candidate i.e., Sri D.Ravi Kumar is against the provision of Rule of Reservation.

The individual has stated that in the proposed seniority list, the column of date of raising vacancies are not mentioned which cause uncertainty of dates on which date the individual was actually being promoted.

The individual has requested to place his name at Sl.No.8 as per Rule of Reservations in promotions.

Reply:

As per G.O.Ms.No.2, Social Welfare (SW.ROR1) Department, dtd. 09.01.2004, para 13 as follows;

“Carry Forward Vacancies: Regarding Carry forward vaccines, if no qualified candidates are available, the following procedure shall be followed;

In case of qualified Scheduled Caste / Scheduled Tribe candidates are not available for a particular panel year the vacancy shall be carried forward to the subsequent year. In the second year if Scheduled Caste/Scheduled Tribe candidates are not available, the vacancies or points meant for Scheduled Caste /Scheduled Tribe candidates may be filled up by candidates from the feeder category based on merit and seniority. The number of such vacancies meant for Scheduled Caste and Scheduled Tribe should be carried forward and filled up first in the immediate subsequent year with Scheduled Caste/Scheduled Tribe candidates.”

Therefore, the roster point No.8-ST(W) arose on 18-10-2016 was unfilled for (2) years, due to non-availability of ST candidate. Hence, filled with OC by merit/seniority. The roster point No.8-ST(W) was shown with Sri D.Ravi Kumar, as per merit cum seniority.

Further, the services of Sri A.Laxmaiah in the cadre of Junior Assistant was regularized w.e.f. 19.05.2019 vide CCT's Ref.No.C/139/2012, dtd. 02.08.2019. Therefore, he is deemed to be acting as regular Junior Assistant w.e.f. 19.05.2019 only. Later, he was promoted as Sr. Assistant on 20-07-2021 and accordingly, his name was placed at Sl.No.19 of the proposed seniority list as per lower category seniority list of Junior Assistants and date of joining as Senior Assistant only.

Therefore, the request of the individual for inclusion of his name at Sl. No. 8 is hereby rejected.

ii) Objection of Sri T.Srikanth, Senior Assistant: The individual has stated that in the proposed show cause notice, his name was not included. He stated that he was promoted as Senior Assistant vide CCT's Ref.No.C1/130/2009, dtd. 20.07.2021 and also his probation in the cadre of Senior Assistant was declared vide CCT's Ref.No. C/1212/2022, dtd.12.10.2022 along with others. Other names whose probation was declared are placed in the proposed seniority list, but his name was not included.

The individual has requested to reconsider and include his name in the seniority list.

Reply:

The seniority of Sri T.Srikanth in the cadre of Junior Assistant in O/o Commissioner (CT), Telangana, Hyderabad is yet to be finalized. However, the individual was temporarily promoted as Senior Assistant purely on adhoc basis as per provisional seniority of Junior Assistants vide CCT's Ref.No.C1/130/2009, dtd. 20.07.2021. Hence, his name was not included in the present proposed seniority list of Senior Assistants. After finalization of seniority of the individual in the cadre of Junior Assistant, his name will be placed in Senior Assistants seniority list.

Therefore, the request of the individual for inclusion of his name in the present proposed seniority list is hereby rejected.

iii) Objection of Smt Shaik Gulnaz Begum, Senior Assistant: The individual has stated that she filed W.P.No.2722 of 2017 against punishment of 4 annual grade increments with cumulative effect awarded to her vide G.O.Rt.No.430, dtd. 08.04.2011. She stated that the Hon'ble High Court vide orders dtd. 20.02.2023 have set aside the above punishment orders and remand back the matter to respondent authorities to conduct a fresh enquiry by duly following contemplated Rule 42 of TSCS (CCA) Rules, 1991 and complete whole exercise within a period of (4) months from the date of receipt of order.

The individual requested to change her name in the seniority list of Senior Assistants.

Reply:

The name of the individual is placed at Sl.No.100 in the integrated seniority list of Junior Assistants/Junior Stenos/Typists of O/o CCT, Hyderabad finalized and published in A.P. Gazette No.79, dtd. 05.06.2010.

Subsequently, on completion of punishment of 4 annual grade increments with cumulative effect, the individual was promoted as Senior Assistant on 17.05.2019. Accordingly, her name was placed at Sl.No. 15 in the proposed seniority list of Senior Assistants, O/o CST, TS, Hyderabad dtd. 28.01.2023.

As per Hon'ble High Court orders in W.P.No.2722 of 2017, dtd. 20.02.2023 and CC No.2658 of 2023 dtd:29-01-2024 filed by the individual, the Inquiry Officer and Presenting Officer were appointed vide CCT's Ref.No.V4/1675/2007 dtd:13-10-2025, to conduct fresh inquiry. After completion of fresh inquiry and as per final decision in the matter, the necessary action will be taken on the request of the individual as per rules. Therefore, the request of the individual is hereby rejected.

In view of the above, the proposed integrated seniority list of Senior Assistants/Senior Stenographers of O/o Commissioner of Commercial Taxes, Telangana State, Hyderabad is finalised as shown in the Annexure which is subject to outcome of SLP's/W.P's/O.A's/C.A's/Appeals pending, if any, before the respective Courts/Appellate forums/authorities.
