In the references 1<sup>st</sup> to 4<sup>th</sup> cited, the final seniority list of the ACTOs of Zone –III for the panel years from 1992 -93 to 2004-05 has been finalized and as such it was proposed to finalise the seniority list of the ACTOs for the panel years from 2005-06 to 2007-08. Accordingly a show cause notice was issued enclosing provisional seniority list vide reference 15<sup>th</sup> cited and published in extraordinary Gazettes of Guntur, Prakasam and Nellore Districts, vide reference 16<sup>th</sup>, 17<sup>th</sup> & 18<sup>th</sup> cited.

In the mean while, the Additional Commissioner(CT) Legal has revised the seniority list of ACTOs of Zone –III for the panel years from 1992 -93 to 2004-05 vide reference 19<sup>th</sup> cited. In view of revision of seniority of ACTOs of Zone –III, it was proposed to finalise the seniority list of ACTOs for the panel years 2005-06 to 2007-08, duly observing the procedure mentioned as here under.

The seniority list of ACTOs for the panel year of 2004-05 ended with No. 10, with regard to quota of 10 point cycle and Communal Roster point ended at Sl.No. 32 OC. In view of above the panel year for 2005-06 has begun with the S.No. 1 (10 point cycle quota) and the communal roster point with 33. The carried forward Direct Recruitment vacancies were 76, City List were 7, S.T and S.C vacancies were Nil.

The roster points shown only for rank promotees, since the APPSC is maintaining the roster points 100 for recruitment of Direct Recruit ACTOs.

The Direct Recruit vacancies of 76 are including the following 5 ACTOs 1) Smt. B. Prasanna Lakshmi, 2) Sri M. Murali Babu, 3) Sri P.Abraham Lincoln, 4) Sri E. Srinivasulu, 5) Smt K. Penchala Prameela of panel year 2004-05 and are relegated to subsequent panel years basing on their deemed date of regularization of services in the cadre of ACTO u/r 16(h) of APS & SS Rules,1996 and in pursuance of orders issued by the Government in G.O. Rt. No. 22, Revenue(CT-I) Dept., dt. 04.01.2012 and G.O. Rt. No. 101 Revenue (CT-I)Dept, dt.17.01.2012 and as per instructions of the Commissioner (CT), A.P. Hyderabad, vide CCT's Ref. No. DX1/1356/2010, dt. 12.01.2012, and CCT's Ref.No. DX1/491/2011, dt. 21.01.2012 as the individuals did not pass the prescribed departmental tests within the period of probation or extended period of probation.

The vacancies meant to be filled with Rank Promotees and Direct Recruits for the panel years 2005-06, 2006-07 and 2007-08 have been arrived at as detailed hereunder.

The provisional seniority list of ACTOs for the panel years from 2005-06 to 2007-08 was appended in Annexure –I. Further, the list of ACTOs promoted on adhoc basis for the period from 01.09.2005 to 31.08.2008 but not included in the provisional seniority list was enclosed in Annexure –II.

Accordingly a revised show cause notice was issued duly enclosing provisional seniority list of ACTOs of Zone –III vide reference 20<sup>th</sup> cited and copy of revised show cause notice was placed on the internet accessible at the address w.w.w. apct.gov.in. The said revised show cause notice has been published in extra – ordinary Gazettes (local) of Guntur, Prakasam and S.R.S.P. Nellore Districts vide references 21<sup>st</sup>, 22<sup>nd</sup> and 23<sup>rd</sup> cited with a request to file written objections, if any within 15 days of display on departmental portal/ publication of the revised show cause notice.

Accordingly certain rank promotee ACTOs of Zone –III have filed their written objections under S.C. and S.T category. The contentions putforth by the affected individuals in their written objections have been examined in detail as here under.

### **Objections of Sri M. Venkateswarlu, DCTO.**

- 1) The individual claimed that he belongs to S.T. category by caste “ Lambadi” and was appointed as Junior Assistant on the F.N. of 10.07.1996 in Commercial Taxes Department and later promoted as Senior Assistant on 01.01.2006., subsequently as ACTO and reported to duty on the F.N of 26.03.2006 in CTO’s Office, Vinukonda. During getting promotions from the lower categories his seniority was reckoned from the date of his joining in the concerned categories as and when promoted to the higher categories by observing the eligibility and qualifications prescribed for next promotion cadre besides roster point in the promotion category. Further, he contended that in the revised show case notice, the communal roster point was ended at S.No. 32 in the seniority list of ACTOs from the panel year 2004-05. But as seen from the seniority list of ACTOs for the year 2004-05 , the ST roster point 8 was filled with Sri V. Bhasakara Rao at S.No. 51 after that the ST Roaster point 25 was not filled with any rank promotee. It was further submitted that the seniority list of ACTOs for the year 2005-06 begin with roster point 33 showing his name against S.No. 1. As such he requested to put his name in proper place i.e 25 which is allotted to S.T. general for the panel year 2004-05.

### **Objections of Sri V. Yedukondalu, ACTO.**

The individual claimed that he has been promoted as ACTO from the cadre of Senior Assistant on acquiring a pass in the departmental tests prescribed for the post of ACTO and joined on the A.N of 30.05.2008 as ACTO besides other candidates belonging to S.T, S.C, and O.C categories in the promotion orders vide proceedings Rc.No. 40/2007/A4, dt. 28.05.2008. Among the candidates promoted, Sri S.V. Ratnam, belonged to S.C category included in the panel year 2007-08 at Sl.No. 48, Sri L. M. Gnana Raju OC category included in the panel year 2007-08 at Sl.No. 50 of Annexure -I and his name was not included in the panel year 2007-08 but shown at Sl.No. 55 in Annexure -II in list of ACTOs not found place in the panels. Smt. B.. Kotamma belongs ST category , promoted as ACTO and joined on 18.12.2009 was placed at Sl.No. 41 of Annexure -I in the panel year 2007-08 who is junior to him in all aspects (and was promoted as ACTO after his promotiion as ACTO. Smt. B. Kotamma was placed at Sl.No. 41 of Annexure -I under S.T. Woman category (Roster point 33) notified for S.T. general category but as per Rules Roster point 33 notified for ST general category but not for ST woman category. He requested to put his name at

S.No. 41 under ST general category of Annexure -I for the panel year 2007-08 in the roster point of 33 as he is senior most in all aspects to Smt. B.Kotamma.

**Reply to the above objections at references at 24<sup>th</sup> & 25<sup>th</sup> :-**

As per revision orders of the Additional Commissioner(CT) Legal,Office of the Commissioner(CT), A.P., Hyderabad vide CCT's Ref.No. DX2/392/2012 -2/ Zone -III, dt. 11.10.2012, the name of Sri M. Venkateswarlu has been relegated from the panel year 2004-05 and shown at Sl.No. 11 of Annexure -B. Hence, his name has been placed at Roster point No. 33 S.T of panel year 2005-06 being a qualified S.T. candidate as on date of arising of vacancy i.e on 30.01.2006, superseding the names of the following senior S.T. Candidates in view of clarification issued in Government Memo. No. 8689/C.T. - I/2/2009, dt. 09.11.2009.

As contended by Sri V. Yedukondalu name of Smt. B. Kotamma has been not placed at Roster point No. 33, since the said S.T. Roster Point was filled with Sri M. Venkateswarlu as mentioned above. The S.T. vacancy at roster point No. 58 arised on 15.11.2007 and by that time Smt. B. Kotamma was qualified for promotion to the post of ACTO. Hence, her name has been included in the seniority list of ACTOs for the panel year 2007- 08 at Roaster Point 58 meant for S.T. (Woman). Further, Sri.S.V.Ratnam and Sri.L.M.Gnanaraju have been included in the panel year of 2007-08 of ACTO's basing on their seniority in the lower cadre of Sr.Asst.

**Objection of Sri T. Peter Babu, ACTO.**

The individual claimed for inclusion of his name in appropriate place in panel years from 2000-01 to 2004-05 of zone -III in the cadre of ACTO as his name was approved for appointment by transfer as ACTO with effect from 19.03.2001 vide CCT's Ref.No. DX1/377/2001, dt. 23.09.2010.

**Reply to the above objection :-**

Sri T. Peter Babu, SC(D) Candidate at Sl.No. 60 in the provisional Seniority List of Senior Assistants of Zone - III has been included in the Adhoc Seniority list of ACTOs for 2001 in place of Smt. K. Jayamma as per proceedings of the Special Commissioner(CT), A.P., Hyd. Ref.No. DX1/377/2001, dt. 23.09.2010. Hence, he is not eligible for any S.C. point arised even in panel years 2005-06 to 2007-08 in view of judgement of Hon'ble Supreme Court of India dt. 05.11.2004.

**Objection of Sri M. Prabhakara Rao, ACTO**

The individual claimed that he was appointed as ACTO through APPSC and allotted to DC(CT), Nellore Division, Nellore and reported to duty on 15.11.2007 (The D.R ACTO allotted to Zone - III) as per the Show Cause Notice his date of joining is shown as 24.10.2007 and requested to finalize the seniority list of ACTOs according to merit and pass orders duly rectifying the omission of date of joining.

**Reply to the above objection :-**

The claim of the individual has been examined with reference to records and found to be in order. Hence, request of the individual has been considered.

In the circumstances stated in foregoing paras, the seniority list enclosed in Annexure –I to revised show cause notice dated 22.11.2012 is confirmed.

The final seniority list of ACTOs of Zone –III in Annexure –I enclosed to this proceedings shall be subject to outcome of SLP's/ WP's/OA's/ C.As pending , if any, before the respective appellate or other judicial forums.
